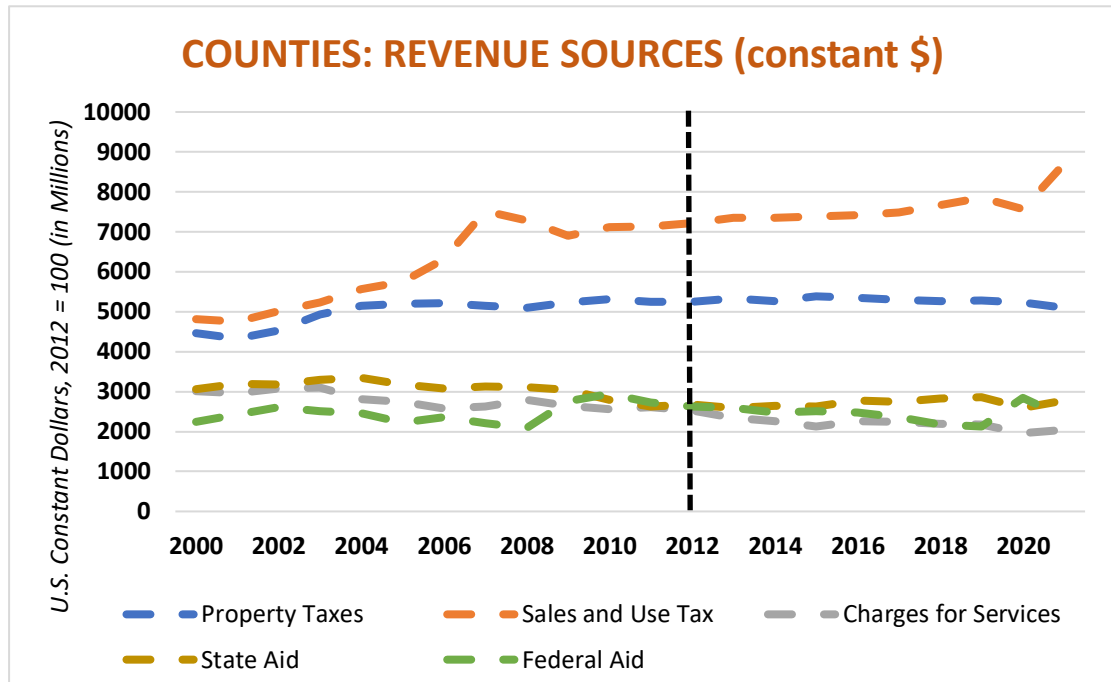


Figure A1. Aggregated Revenues for NYS County Governments, 2000-2021

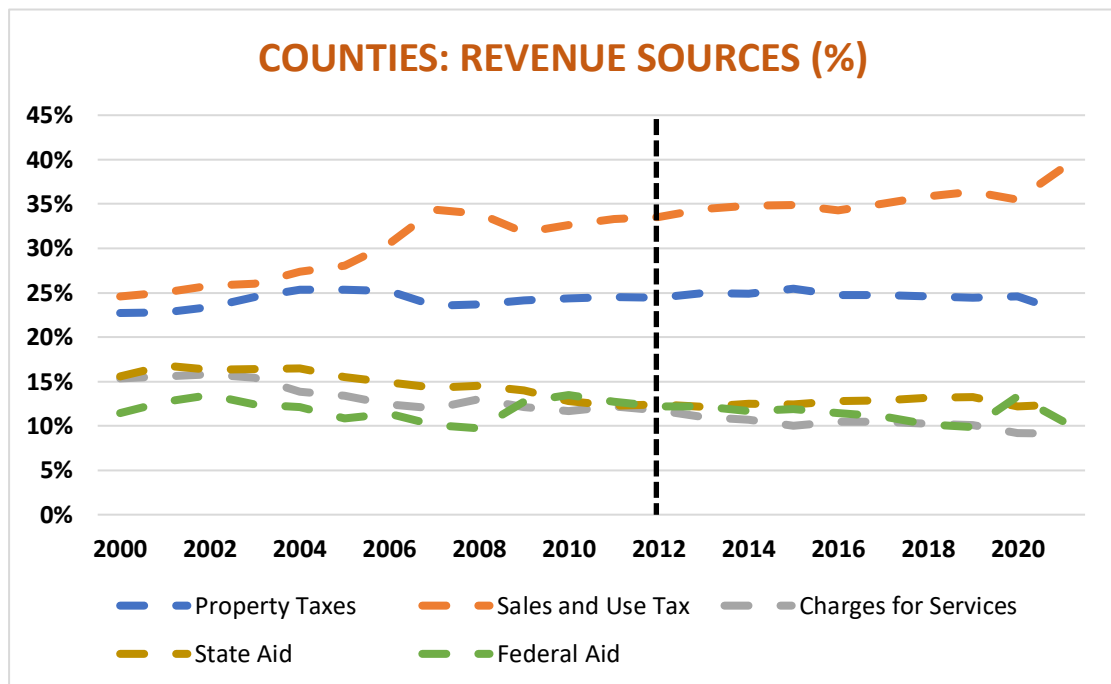


Figure A2. Aggregated Revenues for NYS County Governments (%), 2000-2021

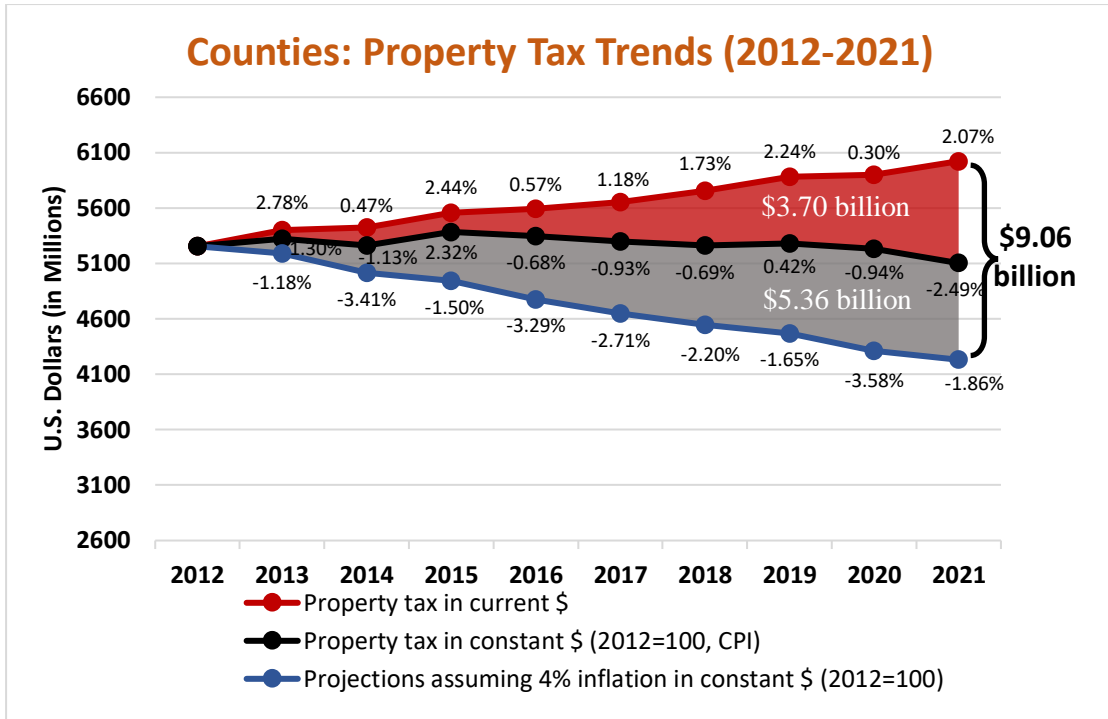


Figure A3. Tax Cap Impact for NYS County Governments, 2012-2021

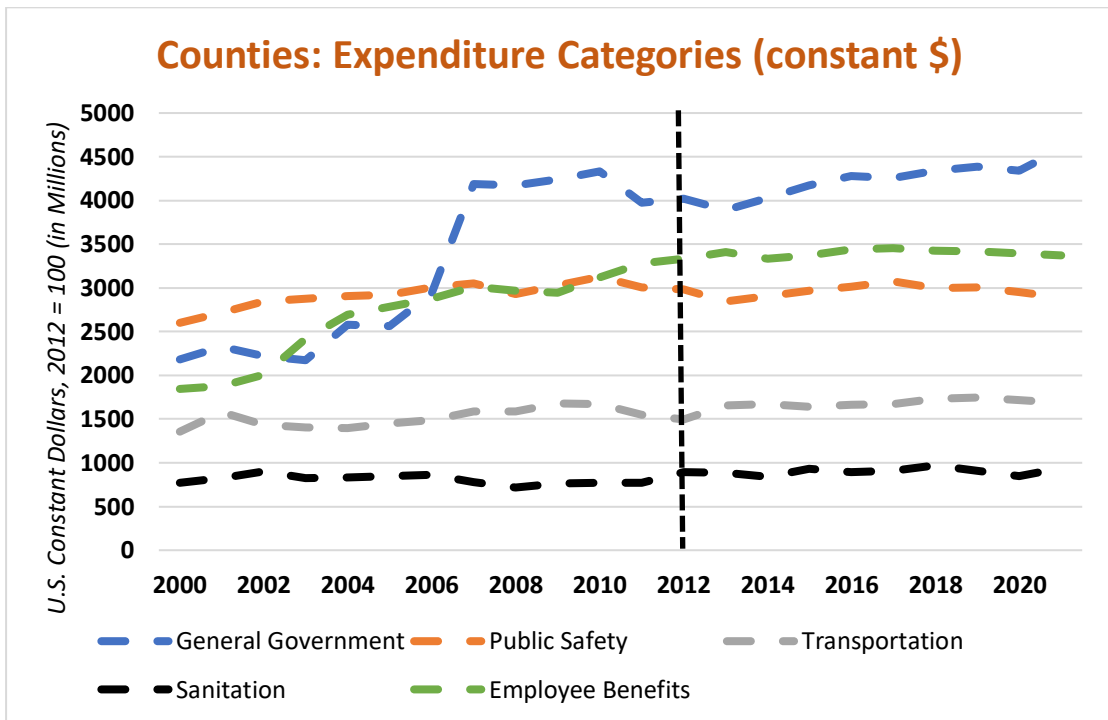


Figure A4. Aggregated Expenditures for NYS County Governments, 2000-2021

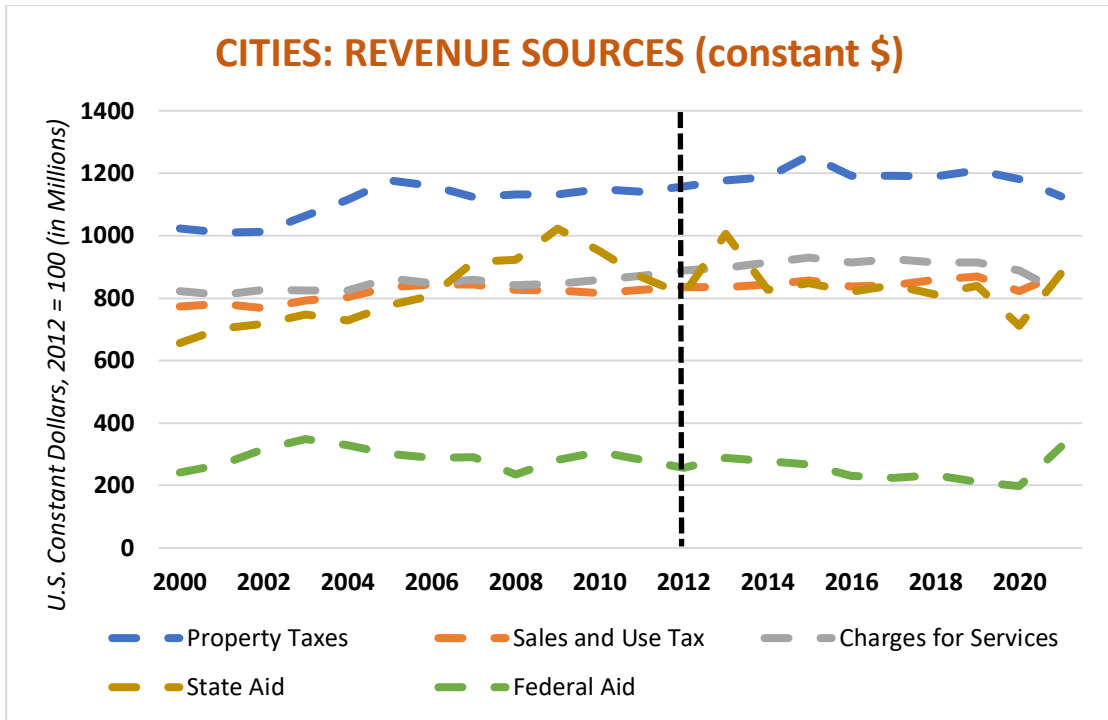


Figure B1. Aggregated Revenues for NYS City Governments, 2000-2021

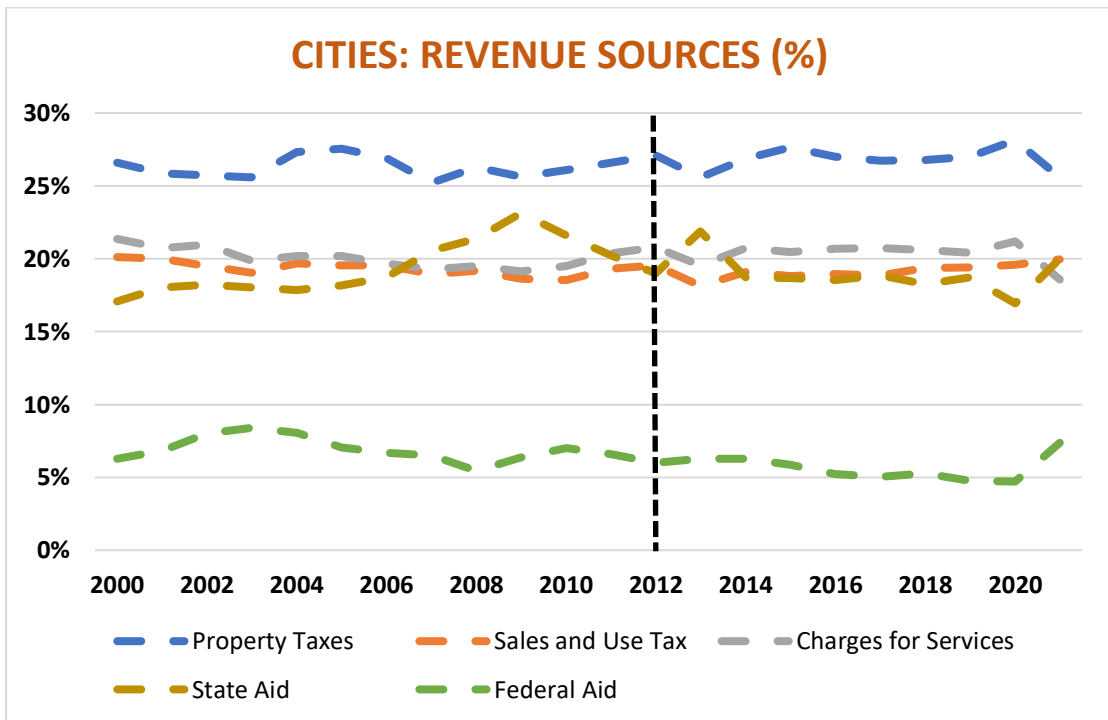


Figure B2. Aggregated Revenues for NYS City Governments (%), 2000-2021

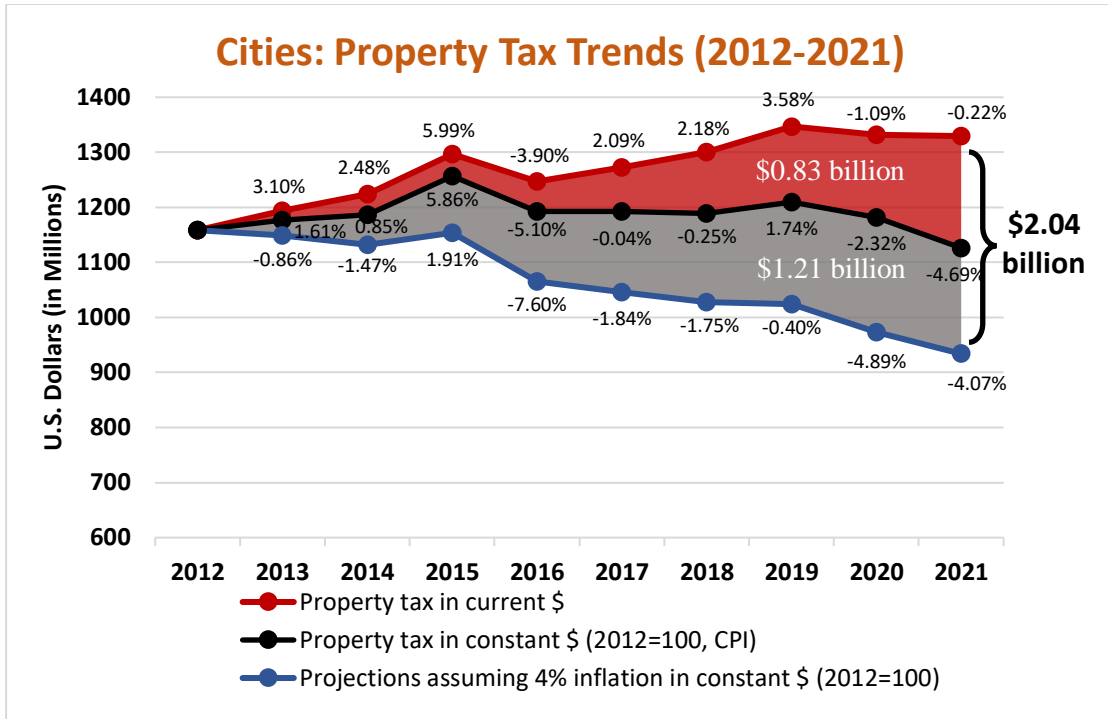


Figure B3. Tax Cap Impact for NYS City Governments, 2012-2021

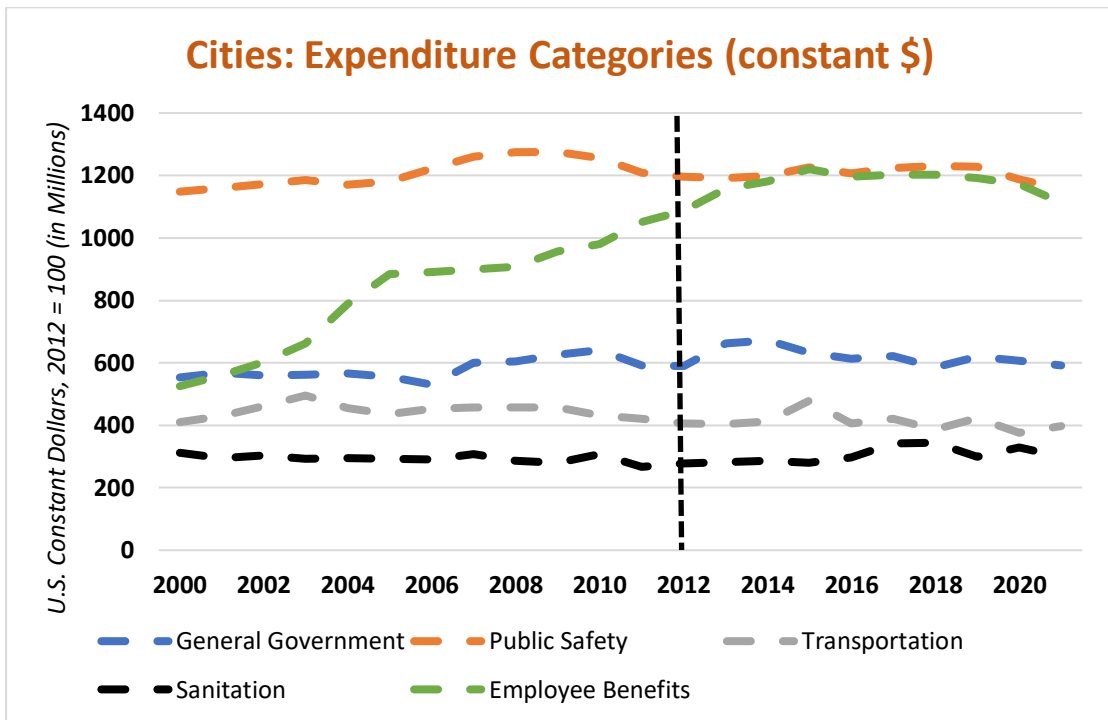


Figure B4. Aggregated Expenditures for NYS City Governments

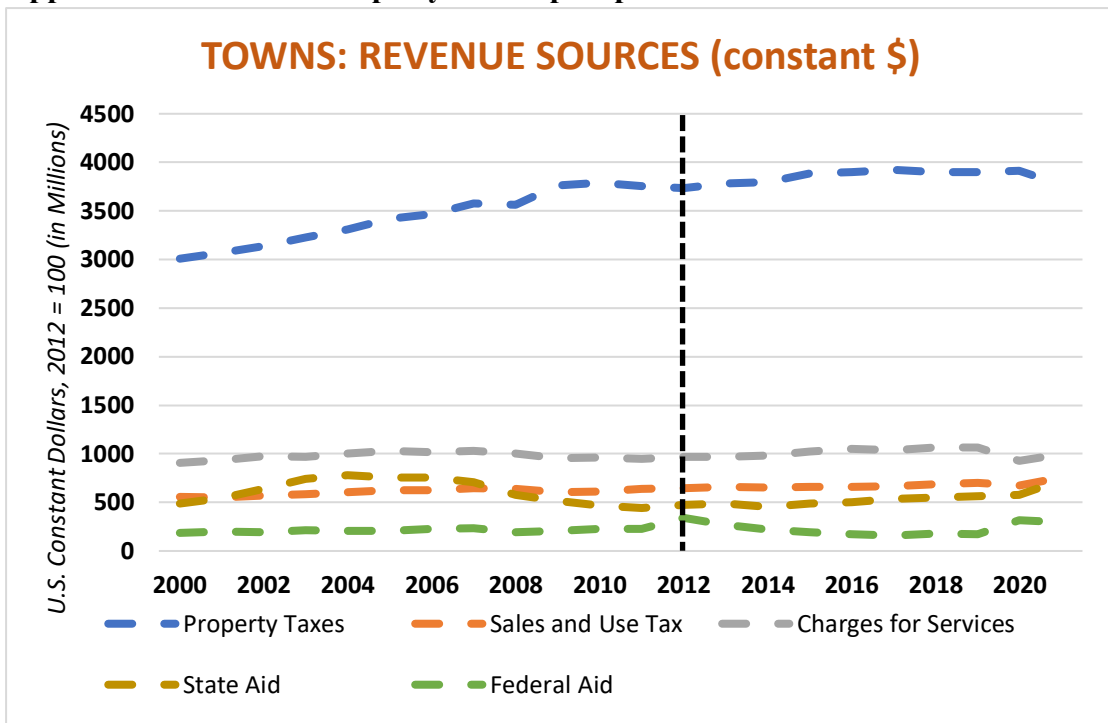


Figure C1. Aggregated Revenues for NYS Town Governments, 2000-2021

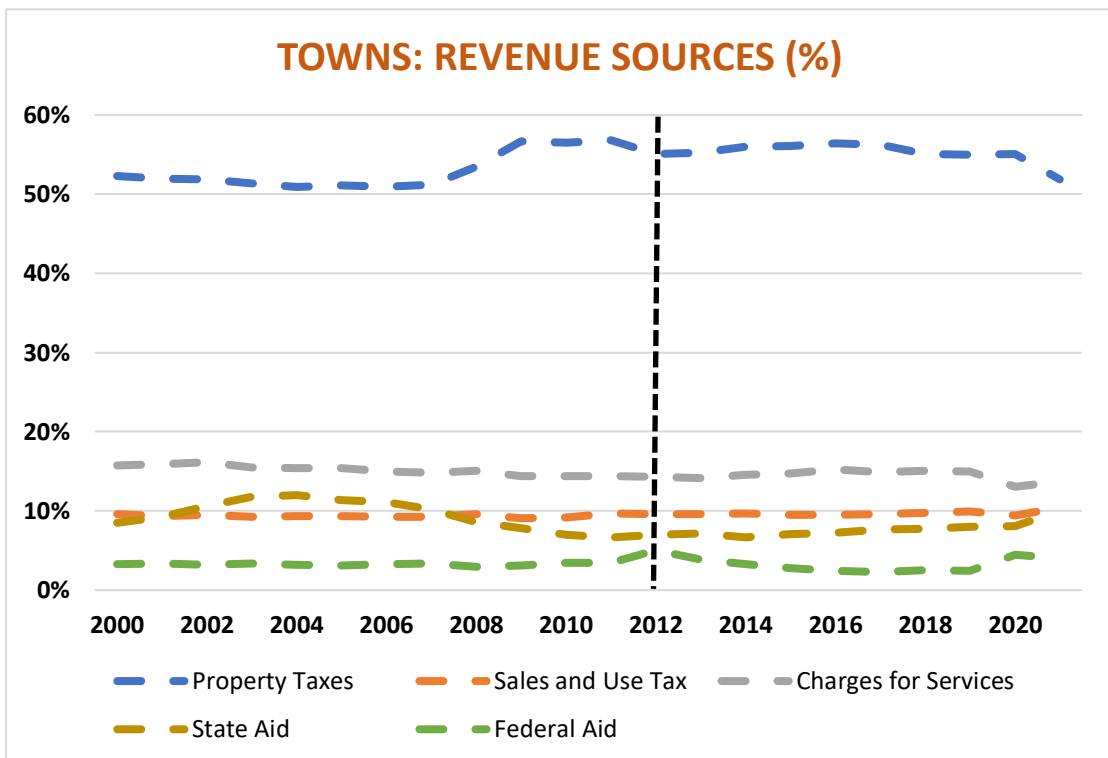


Figure C2. Aggregated Revenues for NYS Town Governments (%), 2000-2021

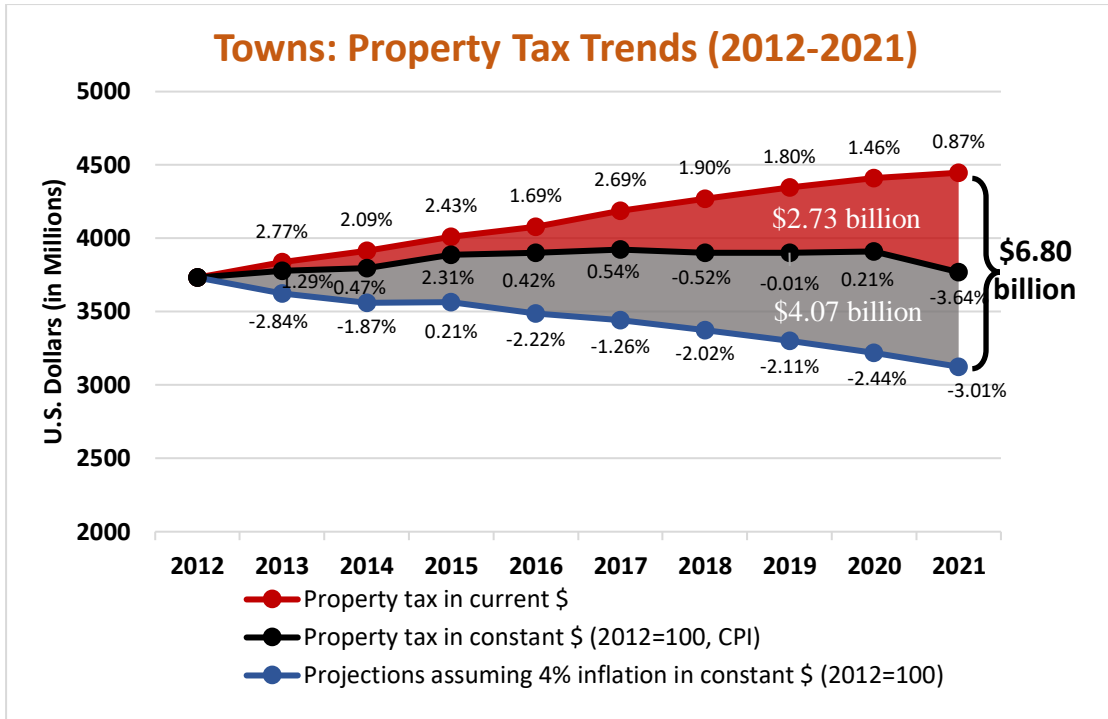


Figure C3. Tax Cap Impact for NYS Town Governments, 2012-2021

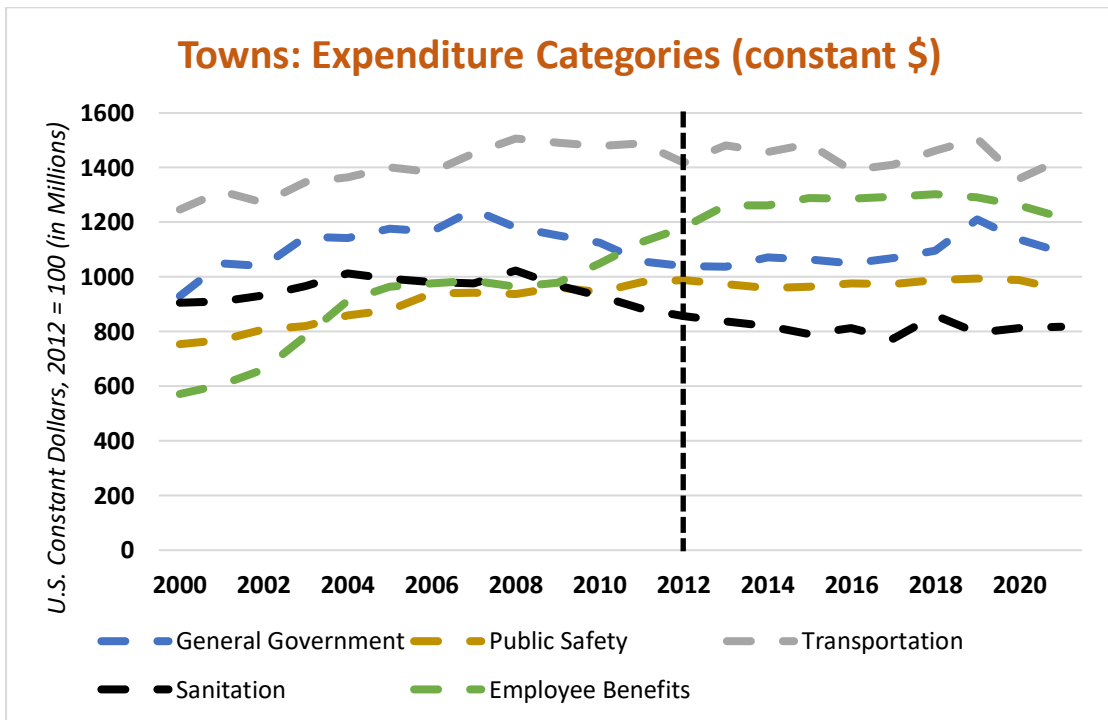


Figure C4. Aggregated Expenditures for NYS Town Governments, 2000-2021

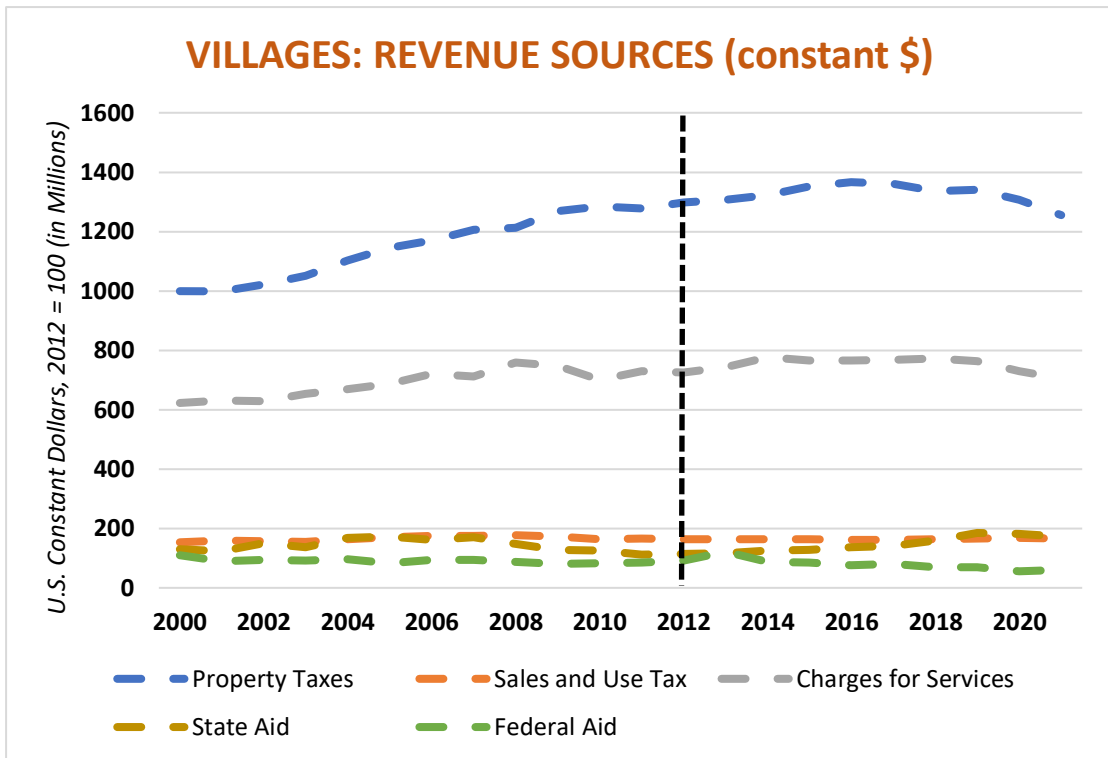


Figure D1. Aggregated Revenues for NYS Village Governments, 2000-2021

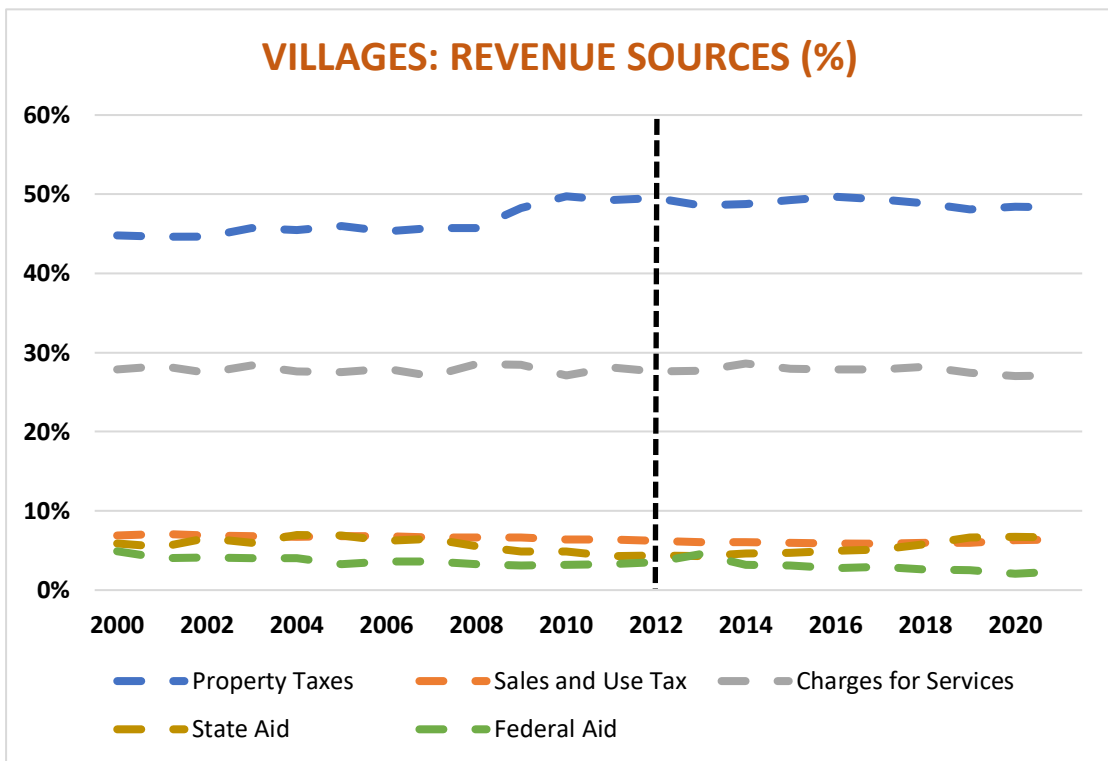


Figure D2. Aggregated Revenues for NYS Village Governments (%), 2000-2021

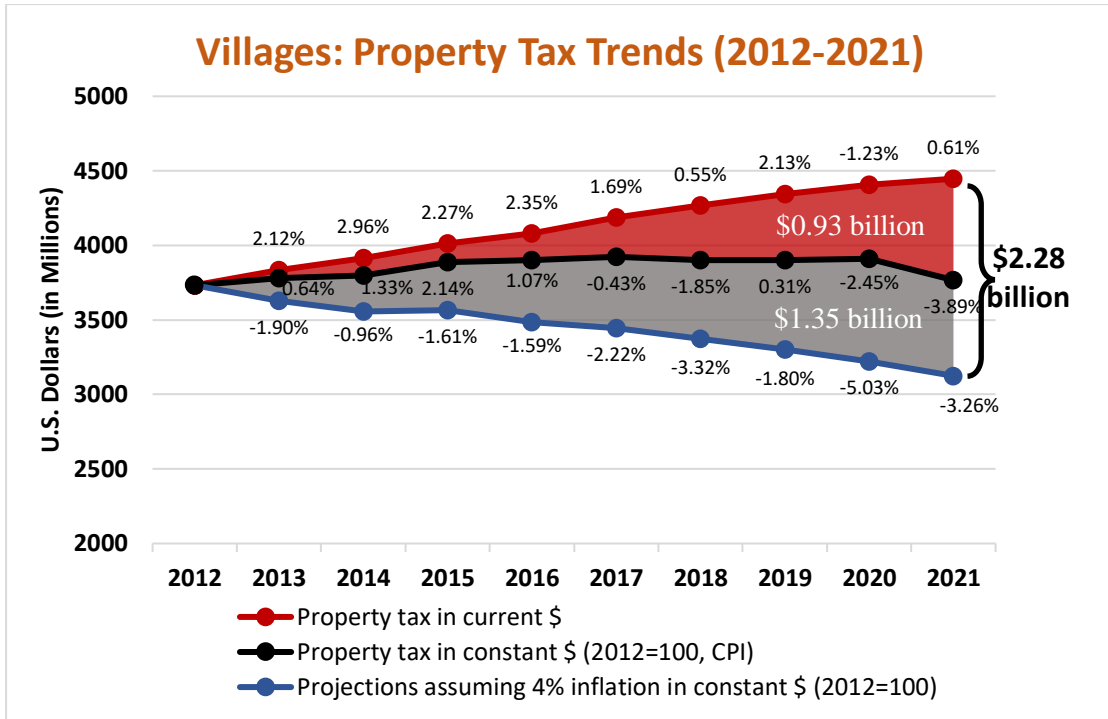


Figure D3. Tax Cap Impact for NYS Village Governments, 2012-2021

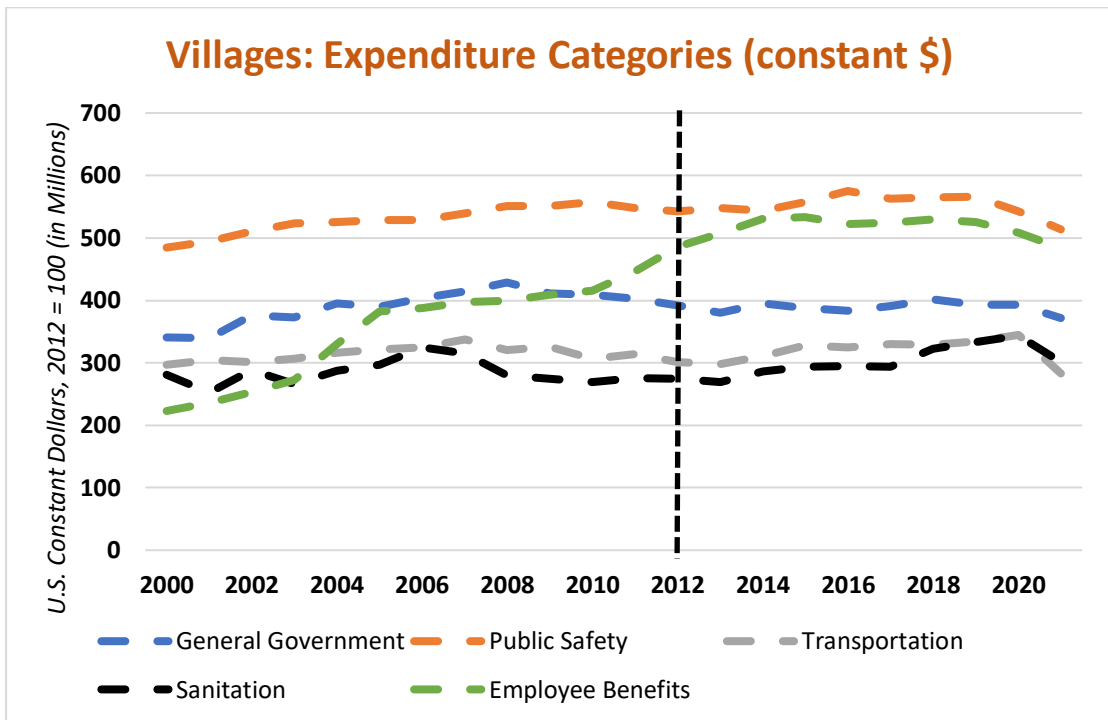


Figure D4. Aggregated Expenditures for NYS Village Governments, 2000-2021
